#### 3. Technical requirement

National deviations:	<ul style="list-style-type: none"> <li>- The Country of Origin shall be marked on each product (if the product is too small, it can be accepted on its direct packaging, this is considered on a case by case basis)</li> <li>- The Country of Origin shall not be abbreviated (e.g. "Made in P.R.C." is not accepted it shall be "Made in China" or "Made in the People's Republic of China")</li> <li>- The wording "Assembled in..." shall not be used as marking for the country of origin</li> <li>- Instruction manuals for household appliances and/or equipment that can be used directly by the consumer, shall be at least in both Arabic and English languages</li> <li>- Instruction manuals for appliances and equipment to be handled only by professional technicians or in the industry shall be at least in English or Arabic language</li> <li>- If an electrical product is intended to be connected to the mains (for example, provided with a plug), it shall have a rated voltage or rated voltage range including 220V (230V accepted) for single phase. if rated frequency is indicated, it shall include 60 Hz (If product is marked 60Hz and internal parts are marked 50Hz only, the test report for the whole appliance needs to be performed and passing at 60Hz)</li> <li>- Electrical plugs shall be UK type plug (squared pin), according to SASO 2203 (Other plug may be equipped for three phase appliances)</li> </ul>
Labelling requirements: (*)	<ul style="list-style-type: none"> <li>- The following markings shall be in Arabic or English: manufacturer name (producing company), country of origin, in addition to the marking requirements as per the applicable standard</li> <li>- Labels, markings and instructions shall be legible, well stuck, and not easy to remove</li> </ul>
Other specific requirements: (*)	<ul style="list-style-type: none"> <li>- All products imported directly from Japan shall be tested for radiation</li> <li>- Energy Efficiency certificates and Energy Efficiency labels shall accompany Air Conditioners, Washing Machines, Refrigerators and Freezers, lamps, rotating electrical machines, water heaters, clothes dryers as required by their respective applicable standards for energy efficiency</li> <li>- Toys (Gulf technical regulation BD-131704-01) and Low Voltage Equipment under list 2 (Gulf Technical regulation BD 142004-1) shall be marked with the GCC mark as specified in the applicable Gulf regulation</li> <li>- Tires shall be accompanied with GCC certificates in addition to the regular conformity documents required and marked with the wet grip and rolling resistance label as per SASO 2857 if applicable.</li> <li>- Biodegradability labels are required for specific polyethylene and polypropylene products</li> <li>- Water conservation labels are required for certain sanitary appliances and tapware</li> <li>- Some products require the IECEE certificate issued by SASO (Mobile phones, mobile phone chargers and batteries, water pumps, dishwashers, television sets, portable computers, <u>lighting products</u>, smart watches and small-scale photovoltaic solar systems)</li> <li>- SASO Quality Mark is required for certain products under the Saudi technical regulation M.A-156-16-03-04 for Gas appliances</li> </ul>
