**NOTICE** to Exporters for requirements of **ICBCM** for shipments not covered by the ICIGI programs and/or considered by the Decisions of the central Bank of Iraq or by the Council of Ministers

### **NEW REGULATIONS**

Regulation 1 : The Central Bank of Iraq issued the circular N°59 on April 2nd, 2012 and the decision N°13 on April 19th, 2012 requiring an official document (inspection report) from an international appointed inspection company for all transfers and letters of credits, such document must be legalized by the embassy of Iraq in the country of origin or the country of supply.

**Auction of Foreign Currency** 

Following to our circular No 59 of 02 April 2012, it was decided as the following : 1.The following shall be added to the clause No. (3) of our above circular :

a.The commercial lists and the certificate of origin of the goods imported directly from the country of origin or the country of supply shall be legalized from the

embassy of Iraq in that country.

b.The importer shall provide an official document from an International appointed inspection company for his imported goods, legalized by the embassy of Iraq in the country of origin or the country of supply. c.The importer shall provide the original bill of lading (B/L) legalized by the

embassy of Iraq in the country of origin or the country of supply which shall include the mode of shipping (maritime, land or air) and such after one month of the amount purchase date from the auction of foreign currency

d.The importer shall provide a customs declaration properly signed and sealed by all border crossing points after one month of the amount purchase date from the currency auction

e.The importer shall also provide the payment order which supports the transfer of the amount to the exporter in the commercial list, except letters of credit.

These instructions are implemented on transfers and letters of credits, such instructions shall be enforced in addition to all amendments mentioned in our current circular to proceed accordingly from 24 April 2012

### **NEW REGULATIONS**

Regulation 2: Iraqi Council of Ministers issued decision N° 223 on June 2nd, 2013 requiring official document (inspection report) from an international appointed inspection company carrying out inspection and related assessment (if required) for goods shipped to Iraqi ministry or related administration in accordance with their specified requirements differing from the ICIGI program

Decision
Of the Council of Ministers
Number 223 for the year 2013

Based on the emergency presentation of the Deputy Prime Minister Mr Rosh Nuri Al-Shawish during the meeting of the Council of Ministers, and the contents of the Economic Affairs Committee letter number SL 566 dated on 2 / 6 / 2013.

The Council of Ministers in its twenty third regular meeting held on 2 / 6 / 2013 has decided the following:

Approving the recommendations of the committee formed according to the decision of the Council of Ministers numbered 212 for the year 2013, concerning the instauration of a mechanism to facilitate the passage through border posts of merchandise and contracted material for the completion of public projects, through the simplification of tax and customs procedures as follows:

- The decision of the Economic Affairs Committee number SL 407 dated on 25 / 6 / 2012 by postponing the inclusion of the imports of the public sector and parties with which it has contracts in the importation license until further notice.
- Contracting the testing of merchandise exclusively by testing bodies contracted by the Ministry of Planning, provided the sectorial party supervises the testing process.
- The issuance of a certificate of origin in a number of copies certified by the commercial attachés.
- Ministries and contracted parties are permitted to import merchandise to Iraq, provided the concerned minister commits to presenting or a certificate of origin within 90 days of importation.
